SC nod to arbitration panel on

New Delhi, Aug 7

THE Supreme Court on Tuesday approved an arbitral panel comprising its two former chief justices, S P Bharucha and VN Khare, to resolve a dispute between Mukesh Ambani-run Reliance Industries (RIL) and the ministry of petroleum and natural gas over the recovery of cost for developing the eastern offshore KG-D6 gas fields.

Justice SS Nijjar while disposing of RIL's plea said that the two arbitrators would appoint a third umpire arbitrator to resolve the differences.

Senior counsel Harish Salve, appearing for RIL, said that the Centre is now willing to get the issue resolved through arbitration and had in a letter dated July

5 appointed Justice Khare as its nominee. Bharucha was recommended by Reliance.

The government till recently was in a denial mode saying that there was no dispute that warrants any arbitration.

The current gas output from RIL's most prolific KGD6 basin has fallen to 29 mmscmd against its projected 80mmscmd, after peaking at 63mmscmd in June 2010.

RIL and partner Niko had requested the apex court to appoint the second Arbitrator under Article 33 of the Production Sharing Contract, entered with the Ministry on April 12, 2000 PSC, and under the Arbitration and Conciliation Act 1996 as the government had in April proposed to restrict the cost recovery for developing the gas fields.

RIL, the world's second



largest oil major (excluding national oil companies), said that serious disagreements with the government have cropped on technical and factual issues including the state of the hydrocarbon reservoir and the need to carry out certain activities. RIL had earlier issued a "notice of arbitration" on November 24 last year
