

# Punjab urban facelift plan gets nod

**Chandigarh, May 21:** The Punjab government on Friday gave a nod to an integrated comprehensive urban development plan to change the face of urban areas of the state within time bound frame.

A high level meeting presided over by the deputy chief minister, Sukhbir Singh Badal approved the Accelerated and Integrated Urban Development Plan to rejuvenate all components of urban development including road infrastructure, sewerage and water supply network, strengthening power transmission network, solid waste collection, landscaping of gardens and traffic management. Badal suggested nominating a nodal officer for every city to coordinate the development process of all agencies for smooth execution of projects.

Badal said nodal officer would also coordinate with various national and international agencies including union urban development ministry, World Bank and other international agencies for timely completion of their projects. Local government and industries minister Manoranjan Kalra and MP Navjot Singh Sidhu also attended the meeting.
