

Realtors' delegation meets FM, demands package for sector

New Delhi, May 19: A delegation of realtors' body NAREDCO met finance minister Arun Jaitley on Tuesday and demanded a package to revive realty sector which include interest subvention on home loans and tax concessions on affordable housing projects.

The delegation, led by NAREDCO president Sunil Mantri, placed before the finance minister the important issues for his consideration which are necessary for the revival of Indian economy in general and real estate sector in particular. The association said in a statement.

The real estate sector is facing a huge slowdown from last few years due to sky-rocketing property prices and high interest cost.

Housing sales have been low, resulting into liquidity crunch and high debt to the developers.

In the meeting, Mantri brought to the notice of the finance minister that housing sector has been kept out of the infrastructure definition, while water supply, sanitation, sewage, solid waste management, road etc which are part and parcel of a housing project are included in the definition.

Posco project fate hangs in balance

By a pathbreaking move, according to the provisions of the Right to Information Act, the firm and sources said it was contemplating pulling out of India.
