

UN NUCLEAR WATCHDOG CHIEF AMANO DIES AT 72



Vienna: The head of the UN's nuclear watchdog, Yukiya Amano, has died after suffering poor health for some time, the International Atomic Energy Agency said on Monday, as international tensions run high over Iran's nuclear activities.

The longtime Japanese diplomat, who was 72, held the IAEA's top job since December 2009.

"The secretariat of the International Atomic Energy Agency regrets to inform with deepest sadness of the passing away of Director General Yukiya Amano," the IAEA said in a statement.

It said that Amano died July 18. But his family had only informed the IAEA late Sunday, "with the specific request not to disclose it until the family funeral had taken place on 22 July in a quiet atmosphere." No details were given about the cause of death.

Anger soared in Hong Kong Monday over a violent clash against pro-democracy protesters that left dozens critically injured in a dramatic display of the political and financial hub.

The city's roiling dark turn late Sunday saw hundreds of men — most wearing white shirts and carrying metal poles — set off a series of government demonstrators returned from another earlier that day.

Footage from the clash was cast live on Facebook and YouTube, with people screaming as they tried to escape the multiple protesters and tear gas at the Yuen Long station subway platform, leaving several people on the floor.

Hospital authorities said at least 10 people were wounded, with one man in critical condition and five others with minor injuries.

Critics roundly criticized the embattled police officers for taking too long to reach the scene and the frantic calls for help from protesters, who called for an attack and then fired tear gas and other weapons on the streets around the station on Monday morning.
